#### **DEFINITIONS**

Restorative Justice: "A process to involve, to the extent possible, those who have a stake in a specific offense and to collectively identify and address harms, needs, and obligations in order to heal and put things as right as possible." - Dr. Howard Zehr, Eastern Mennonite University, Center for Justice and Peacebuilding, Zehr Institute of Restorative Justice

Restorative Classroom Practices: These may include "facilitating learning communities that nurture the capacity of people to engage with one another and their environment in a manner that supports and respects the inherent dignity and worth of all." Examples of restorative practices may include class meetings or community building circles, setting classroom guidelines as a class, and a restorative chat between the teacher/educator and the student after a class or school norm was broken. - Dr. Kathy Evans, Assoc. Professor of Education, Eastern Mennonite University & co-author of *The Little Book of Restorative Justice in Education* 

**Restorative Re-Entry Circles:** This circle practice occurs when a person who did something wrong, the offender, is coming back into the school after perhaps a suspension, or time in prison.

The 2024 online symposium, "Making Connections: Lessons Learned from Practice to Policy in Restorative Justice in Education," builds upon prior online and in-person conferences on the themes of peace education since 2004, which focused on conflict management, human rights, social and emotional learning, peace education, democracy education, civics education, and multi-cultural/global education in traditional and non-traditional education settings. Each year the conferences bring together government representatives, key education stakeholders, and their civil society partners who have relevant legislation or policies and/or programs in place.

This online symposium will **focus on** *innovations* **in the field of restorative justice in education** that are making significant impacts in local, state, regional, and international communities. It aims to strengthen networks of restorative justice in education practitioners and policy-makers in Northeast Asia and beyond. Participants will exchange *best practices*, *evaluation methodology*, *structures for the creation of policy implementation*, *identified obstacles to success*, and *new and innovative uses of training, resources and technology*. By making connections both between practice and policy and between different contexts, this symposium creates a space to showcase lessons learned and build on best practices from diverse contexts to further restorative justice in education.

**Note** - Presenters are asked to provide emphasis on positive change strategies. At the start, they are asked to begin by briefly providing the context for their work – to describe the challenge in the community and then offer strategies used to address these challenges. We invite proposals for organized panels, discussions, workshops and other creative contributions on the topics of:

- Best practice program models for teaching and training at the national/regional/state/local level
- Strategies for creating related policy/standards/legislation at the national/regional/state/local level;
- Strategies for evaluating related programming;
- Strategies for policy creation/implementation;
- Discussions that address any of the following:
  - What does scholarly research, across the disciplines, offer with regard to the conference themes?
  - What political, social and economic structures best assist communities implementing conference themes and innovative policies and programs?
  - What case studies, negative and positive, can help us navigate these issues?

### **Criteria for Evaluation and Selection**

Priority will be given to proposals that share implementation of good practice in *Making Connections: Lessons Learned from Practice to Policy in Restorative Justice in Education* specifically at a local and/or global level in policies/standards/legislation and macro-level capacity building in states, regions, or countries. Proposals should include how the policy, practice, and/or research is culturally tailored to the demographics of the region in which it is being applied and what form of evaluation is being used in order to show effectiveness.

- Relevance and interest of topic
- Demonstrated value and originality of topic
- Appeal to varied categories of participants
- Qualifications of presenter
- Demonstrated experience and previous accomplishments
- Creative mode of presentation (assuring varied modalities among the presentations).
- Indication of presentation methods which are suitable for the content
- Presentation of a well-thought-out argument
- Topic of value to other social entrepreneurs/policymakers/educators/researchers/prevention specialists working in the area of peacebuilding
